Pause and Ponder

October – Jesus Heals an Official's Son at Capernaum in Galilee (John 4:46-54) Virtuous Action – Asking for Assistance

The second sign found in the Gospel of John is one of healing and trust. In this passage, the official not only travels far to find Jesus and ask for assistance for his son, but also trusts implicitly that what Jesus says will come true. The dialogue between the official and Jesus is brief and concludes with the words of Jesus, "You may go, your son will live." There are no further questions from the official. He knows that what Jesus says, Jesus does.

Such amazing trust has the official in the words of Jesus! The passage challenges me to evaluate my trust in the Word of God. As often as I read Scripture passages in which the Apostles, disciples, and others are called to trust in the Lord's promises, I question my trust level. Do I want indications, reassurances, or signs before I trust the Lord? How far will I go in my level of trust?

This week, let us assess our trust level in Jesus and his promises and pray for an increase of faith in the Lord.

Action Required

Official School Enrollment – All Catholic school (stand-alone preschool, elementary and secondary, parish, regional, diocesan, and private) are reminded to submit the Official School Enrollment (enrollment as of September 30) by the end of the day on **Monday, September 30**. Use the Google sheet designed for this purpose. If you have any questions, please call the Catholic Schools Office.

Federal Programs Confidential Family Survey – Family Survey Information is to be returned to the Catholic Schools Office by **Friday, October 4.** Be mindful that it is beneficial to your school to aim for the highest number of returns from your families. In order to insure that all your surveys are complete and eligible for submission to the respective school districts, we ask that you provide the following reminders to the individual who is responsible for collecting, checking, and sending your documents.

BEFORE SENDING SURVEYS TO CSO, REVIEW EACH SURVEY FOR THE FOLLOWING INFORMATION:

- Is your <u>School ID #</u> listed on the top right corner of each Family Survey?
- Is the Family ID # listed on the survey?
- Have both sides of the survey been completed? *Incomplete surveys are not submitted.*
- Is the correct School District listed for the student's residence?
- When returning copies, have you copied both sides of the survey?
- Is all information on copied surveys legible?
- Return only hard copies of surveys. Emailed or faxed copies will not be accepted.

New Castle County Consortium – Title I referrals are due to your respective school districts. With the start of October, we wish to see Title I services get underway. Please forward any outstanding referrals by the end of the upcoming week.

October Reflection – The October reflection is provided for use with your faculty and staff.

High School Open Houses – Please remind every sixth, seventh, and eighth grade student in your school about High School Open House dates and encourage their families to visit Catholic high schools. Encouragement from administrators and teachers goes far with parents and students!

High School Admissions Process – A Correction – In prior information distributed about the information to be provided for the admissions process to high school, it stated that the Renaissance Longitudinal Report was the summary of standardized progress to be submitted. It should have stated the Renaissance Annual Report. Since Renaissance has been in use only for the 2018-2019 school year, one Annual Report is on file for eighth grade students who took the assessments last year. This report, along with the September testing results, should be provided to parents for high school admissions. Please share this information with the Admissions Director at your school since they, too, were given the incorrect information.

CSO Intranet – In visiting the CSO Intranet you will find that the Principal's Page has been removed under Staff Pages and a separate drop-down menu has been created under Administrators. The password (CSO1868) for administrators remains the same. Please remind teachers and other staff members who need access to the CSO Intranet that their password is CDOW1868.

School Religion Leaders' Meeting – Please remind your School Religion Leader (Curriculum Coordinator or Department Chair) about the meeting on **Wednesday, October 2**, at the Catholic Schools Office. Elementary Coordinators will meet 1:00 – 3:00 pm; Secondary Chairpersons will meet 2:00 – 4:00 pm. From 2:00-3:00 pm a presentation will occur for all School Religion Leaders – elementary and secondary. Please remind your School Religion Leader about this annual meeting.
