# Catholic Identity – Assessment of Religious Knowledge

For the past two years elementary school students in Grades 2-8 have taken the Assessment of Religious Knowledge (ARK). At the October Administrators' Meeting, diocesan level results were shared with schools and individual school results, available through ARK to each school, were distributed for review. The purpose in taking ARK is to identify areas of strength for students as well as areas in which they may strive to grow. It is hoped that this national assessment opens a conversation about knowledge, beliefs, and behaviors throughout schools in the classroom, at faculty meetings, and with families.

Average Student Score – 60<sup>th</sup> percentile Knowledge Score – 49<sup>th</sup> percentile Average Belief & Behavior Score – 70<sup>th</sup> percentile

The knowledge score assesses **what students know** based upon the pillars of *The Catechism of the Catholic Church*. The knowledge of the *Catechism* is developed through the approved religion textbook series of the United States Conference of Catholic Bishops used in schools of the Diocese of Wilmington.

The belief and behavior score assesses *how students demonstrate their beliefs by their behaviors*. While students may not be able to label content, they may understand and live its message. They learn beliefs and behaviors in school and at home through the witness of educators and parents.

Overall, based upon the results of students who took ARK last year, they were *strong in Prayer* and **need to** focus on Virtue.

#### Safe Environment Forms Due

The Asbestos Report (all elementary and secondary schools) and the Environmental Issues Management Report (parish and diocesan elementary and secondary schools) are due **October 31**. Forms may be found on the CSO intranet under Administrator Resources> School Environment Reporting Forms.

## High School Placement Test

November 11-12 are the High School Placement Test dates for Padua Academy, St. Elizabeth High School, Saint Mark's High School, and Saints Peter & Paul High School. Elementary schools are asked to remind students and their parents or guardians weekly of the registration deadline in school communications.



# Introductory Period Reviews

Introductory Period reviews of new staff members, as described in Policy 111 in the *CSO School Personnel Handbook*, are to be completed within the first 90 days of employment. Please check the hire date for new employees and complete the reviews in a timely fashion. All reviews should be completed no later than before the Thanksgiving break.

Introductory Period reviews are retained at the school level with a copy given to the new employee. A document listing the school, new employee, and position of each employee reviewed is due to the Catholic Schools Office when all reviews are completed, but no later than the Tuesday before the Thanksgiving break.

New teacher reviews should be based upon one formal observation, one classroom walk-through, and one beyond-the-classroom observation. Other employee reviews should be based upon the job description of the role of the employee.

The review may be completed in narrative form. For teachers, it should address the headings of each section found in the Professional Standards for Teachers. For other employees, it should address the major responsibilities of the position.
